

That if my name is found to be included in the prospective voter list of any Bar Association(s) where, as on date the election process has started then either the Declaration or Election Committee of NCLTBA would have right to strike off my name from the voter list (tentative/final) even prior to or on the date of the NCLTBA Elections 2024.

- 6A. That I state the requirement of clearing the All India Bar Examination had not been stipulated prior to my enrolment as I had graduated law prior to the academic year 2009-10. I have attached self-attested copies of my Enrolment Certificate/Identity Card issued by the Bar Council of Delhi and L.L.B.Degree.
